

FURTHER ORDERED, that said petitioner notify all persons desiring to be heard to appear at said hearing, when and where they may be heard upon the question whether the prayer of said petition may be granted consistently with the public good, by causing an attested copy of this order of notice to be published once in a daily newspaper having general circulation in that portion of the state in which operations are proposed to be conducted, such publication to be not later than May 8, 1978, such publication to be designated in an affidavit to be made on a copy of this order of notice and filed with this office; and it is

FURTHER ORDERED, that any person opposing the application, pursuant to NHPUC Rules of Practice and Procedure, Rule C-16, must notify this Commission by letter by May 15, 1978, giving name, intention to appear at the hearing and reason for opposition.
