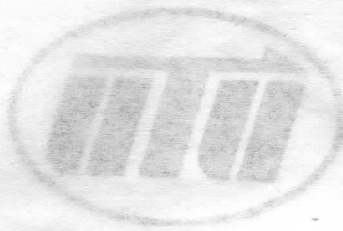

Dear Mr. Staples: recent telephone conversation relative to the new water cooler for the yard office here at Manchester, and further. As yet nothing has been done in securing a replacement for this no longer operable water cooler.


As you might well imagine the water that is now coming from the present cooler has a taste and odor which is not a healthy situation. I must then request that this cooler be removed and a new one installed.
